A presentation was made to the Town of Oro Valley Park and Recreation Advisory Board on Tuesday, November 15, 2022. The Parks & Recreation Advisory Board (PRAB) acts in an advisory capacity to the Town Council in matters pertaining to parks and recreation, parks design, open space and trail use (prior to the review comments being submitted to other Boards, Commissions or the Council). The purpose of the presentation was to provide a project overview of the scope of work and schedule for the master planning of the Vistoso Trails Nature Preserve and to receive suggestions regarding the future programming for the facility. Sites Southwest presented the following information:

- 1. Introduction of consultant team, Sites Southwest and The Acorn Group, and services to be provided, environmental planning, landscape architecture, interpretive planning, and educational programming.

Oro Valley's Mayor and Council are committed to providing high-quality municipal services and responsible development. Through the Town Manager, the Mayor and Council provide policy direction by adopting rules, regulations, and procedures to meet community needs. The purpose of the presentation was to provide a project overview of the scope of work and schedule for the master planning of the Vistoso Trails Nature Preserve and to receive comments regarding the future programming for the facility. At the conclusion of the presentation, the following comments were received from Mayor and Council:

- 1. Councilmember Solomon expressed concerns regarding the future/unknown costs to maintain the preserve and asked what it would cost to maintain the preserve on an annual basis. Oro Valley Park and Recreation Director Kristy Diaz-Trahan explained that the maintenance costs will be addressed in the annual park and recreation department budget and that these costs will be determined based on the approval of the final master plan document. Currently, maintenance of the Preserve is being outsourced. The current fiscal year has \$220,720.00 identified for general landscaping, which is outsourced to Brightview Landscape and includes the removal of invasive plant materials as well as general maintenance. There is an additional \$350,000.00 for capital improvement work that includes the master plan, restroom, and cart path repair. During the next fiscal year funds will be spent to fix the cart path, washes, and additional areas of erosion. The consultant has been directed to create a master plan that can be developed in phases as funds and grants become available. Issues concerning future implementation and maintenance funding and budgeting will be addressed during the budget approval process with the Town Council.
- 2. Vice-Mayor Barrett asked for more information on the services that Acorn will be providing. It was explained that Acorn is working with local schools to develop curriculum that incorporates the Preserve. Additionally, it was stated that there is tremendous potential for biology classes and projects to be connected to the preserve including the mapping of plant material and measurement of plant growth.
- 3. Vice-Mayor Barrett stated she thought it was very important that the site be replanted to remove the "scorched earth look."
- 4. Councilmember Bohen asked if there is a cost estimate for the improvements and maintenance. Oro Valley Park and Recreation Director Kristy Diaz-Trahan explained that this information will be included in the master plan.



- 5. Councilmember Nicolson asked what grants were available. Sites Southwest stated that grant sources will be identified based on the master plan programming and will be included in the final document.
- 6. Councilmember Jones-Ivey stated that she had meet with Sites Southwest and is looking forward to the development of the master plan.
- 7. Oro Valley Park and Director Kristy Diaz-Trahan stated that standards need to be developed for improving the Preserve buffer zones that are adjacent to residents and that the process for submission, approval and execution will need to be established.

During the community outreach and public participation phase of the Vistoso Trails Master Planning process, the Town of Oro Valley hosted a community workshop meeting for the purpose of receiving comments and programming input from community members. The meeting was held at the Oro Valley Public Library from 10:00 AM to 4:00 PM on Wednesday, November 16, 2022. The workshop format included a sign-in station that was monitored by representatives from the Town of Oro Valley Parks and Recreation Department and the consulting team. The meeting greeters:

- Welcomed attendees
- Requested that attendees sign-in, complete a comment card and survey
- Requested that attendees view the information located at the image board station
- Requested that attendees visit one of the two (2) programming stations manned by representatives from the consulting team

The image board station was comprised of a series of presentation boards that outlined the master planning process and schedule, and included photographs of the following potential programming elements:

- Trail types (including nature trails, walking trails and multi-use paved trails)
- Trail amenities (including pervious parking areas, rest areas, site furniture, signage, and public art)
- Site structures (including pavilions, shade structures, overlooks and wildlife viewing blinds)
- Nature play spaces (including natural structures that are woven into the existing terrain)
- Passive open spaces (including outdoor classrooms)

An existing conditions base map of the project site was located at each of the two (2) programming stations, which were manned by representatives from the consulting team. The workshop format allowed attendees to review the initial Preserve base map, ask questions and offer suggestions for proposed Preserve improvements and desired amenities. Most comments received were focused on preserving the character of the site and creating amenities that would allow users to enjoy and engage with the natural environment. Many of the attendees proposed the following improvements/amenities:

- Provide separate trails for walking and biking
- Provide loop trails for walking and biking
- Provide neighborhood connection trails
- Keep the area natural and protect the mountain views
- Revegetate the site with native plant material
- Provide limited parking
- Provide environmental education opportunities for the community



- Turn the former pond into a site amenity
- Create shaded resting areas along the trail(s)
- Create a volunteer network to assist with funding, maintenance, and planting
- Create buffer guidelines to prevent the clearing of Preserve property that lies adjacent to residential areas

It should be noted that there were also requests for the inclusion of a disk golf course, a dog park and mountain biking trails. Participants were informed that these uses are not permitted based on the conservation easement agreement. It was further clarified that while the easement does not support a mountain biking park and that changing the landscape for an intensive use does not comply to the spirit of the easement, it does allow for passive recreational biking that includes the use of road bikes, mountain bikes, e-bikes, etc. Additionally, comments regarding potential traffic safety and impacts to the adjoining residential communities were received.

The information collected from this community workshop meeting will be incorporated into the Vistoso Trails Master Plan and will be used to assist with the development of the Preserve programming.

At the conclusion of the presentation, the following comments were received from attendees:

- 1. Use a turbine blower to clean trail. These are used on golf courses and work well.
- 2. Less is more. Minimize the number of restrooms and improvements. More benches and shade areas would be good but, do not add any more parking.
- 3. Less is more. Keep it desert. Preserve will be a draw to the world. After liability items are fixed, redo pond. Use maintenance area for parking and don't add any more parking.
- 4. Pond is most important and do something for nature and wildlife, but it must be affordable. Fire Department might help with funding if the pond can be used for firefighting. Grants are available to help build back the pond.
- 5. Less is more. Restore the pond.
- 6. No more ground lights. Use maintenance yard for education building and give access to all. Possible bump out parking in a few places. Minimal pond restoration for wildlife habitat. Riparian wetlands would be good.
- 7. Pond needs to be developed into something. Maintain area between street & pond to make it look better. Schedule for restoration of the fairways needs to be accelerated.
- 8. Pond could be wetlands.
- 9. Prevent overuse. Keep it as natural as possible. Regrow desert areas. Bikers are dangerous!!!
- 10. Include a place for bridge players.
- 11. Post a 5 MPH speed limit on the trail and make the trail one way only for bikes.
- 12. Create separate trails for bikers and walkers.
- 13. Limit height of buildings. Continue effort to get rid of deadwood and patching of concrete cart path.
- 14. Add shade, trees, and water stations along trail for people and animals.
- 15. Fire buffer at residential areas what is going to happen???



- 16. Less is more. Do not add parking by the school. That area seems to be an animal corridor and should be protected.
- 17. There is less cursing since the golf course is gone. Less is more.
- 18. Fill in the pond and get rid of it. Sand traps ugly and get rid of them. Maintain the cart path better.
- 19. How many parking lots are going in? No crowded parking lots.
- 20. Pond 2.0 reimagined to wildlife habitat. Wildlife need water. Attract and nurture as many species as possible. Add nest areas. Accelerate the return of greens to desert. Include 5 MPH speed limit on cart path and one way traffic pattern.
- 21. Jake Smith prepared a 175-page document of birds, plants, etc. that live in the preserve and is on website.
- 22. Do everything we can to allow users to view the mountains and incorporate kids through education.
- 23. Hope that there are a lot of grants to help it all get built.
- 24. Find money in Oro Town budget to build and maintain the Preserve.
- 25. Get garbage cans and dog stations along cart path.
- 26. Add a management staff person on property so that users know that there are eyes on the Preserve.
- 27. Waterfall is eyesore, fix it. Add grass and picnic area near pond.
- 28. What are the plans for the fairways? Leave them open.
- 29. Holes #4 & #5 have best mountain views.
- 30. Developer of six (6) acres is building one hundred and forty (140) units with Preserve as main selling point.

COMMUNITY SURVEY



Analysis of Vistoso Trails Nature Preserve Community Input Survey

Overview

The Town of Oro Valley invited the community to participate in the master planning process for the Vistoso Trails Nature Preserve (formerly known as the Vistoso Golf Course). The Parks and Recreation department administered a survey to gather input from community members to help plan and design a community-focused space that reflects the needs of Oro Valley residents at Vistoso Trails Nature Preserve (Preserve). The survey gathered input on future site improvements, visitor experience and land-use management that will be used to develop the Preserve's Master Plan.

Key findings include:

- The survey showed that the community is aware of the Preserve. However, we should be cautious of a self-selection bias inherent in the opt-in nature of the survey.
- Given the high response rate among those who frequently visit the Preserve (75 percent of respondents visit at least once a month), we should consider this survey skewed towards current users.
- There is broad agreement on the amenities sought at the Preserve.
- Frequent visitors tend to be pedestrians. Less frequent visitors tend to drive a vehicle.
- Those who have never visited may be drawn in with greater number of dirt trails, shorter distance loops and trailheads.

Methodology

The survey was available both online and on paper copy.

Overall, 622 surveys were completed over the course of November 2022. The overall results have a precision of at least +/- 3.9 percent at the 95 percent confidence level (meaning we can be 95 percent confident that the survey results reflect the overall opinions of Oro Valley residents to within plus or minus 4 percentage points on any answer).

However, participants were able to choose whether to participate in this survey, thus introducing a possibility of self-selection bias. Self-selection bias occurs when the group that chooses to participate is not equivalent to the group that opts out. We can generally assume that individuals that took time to respond to a survey regarding the Vistoso Trails Nature Preserve are more likely to be users of the Preserve than those who chose not to participate.

Q1: Are you familiar with the Vistoso Trails Nature Preserve?

Respondents to the survey were very familiar with the Preserve – nearly 97 percent of respondents were very or at least a little familiar with the Preserve.



Q2: Have you visited the Vistoso Trails Nature Preserve?






Most respondents visit the Preserve on foot.







Section 2: Results Based on Certain Respondent Characteristics

Frequent Visitors

319 of the 622 respondents (51.3 percent) indicated that they were frequent visitors, using the Preserve about once a week, multiple times a week or even daily. These frequent visitors were 28 percent more likely to walk or jog than respondents overall.



Frequent users showed the same general preference for amenities at the Preserve as respondents overall. Within the open-ended comments for other amenities, frequent users commonly agreed with respondents overall in voicing a desire for restrooms, a lake/pond, natural vegetation, trash receptacles and signage.

There were some differences lower in the list of other amenities. However, the number of respondents becomes quite small at that point, limiting the conclusions we should draw.



Respondents Who Had Never Visited the Preserve

97 respondents had never visited the Preserve. Yet this group still knew about the Preserve with 79 percent expressing some level of familiarity (very familiar or a little familiar).



Those who have never visited showed a greater interest in pedestrian amenities (dirt trails, shorter distance loops and trailheads) than respondents overall and were less interested in water features and educational signage.

Conclusions

To be discussed and determined. Key findings may include:

- The survey showed that the community is aware of the Preserve. However, we should be cautious of a self-selection bias inherent in the opt-in nature of the survey. It is difficult to assess the amount of self-selection bias in a survey, yet we can be reasonably sure it exists. Other outreach methods may reflect the opinions of different groups within the Town. Use of the Town's Flashvote survey instrument may offer the opportunity to benchmark the results of this survey.
- Given the high response rate among those who frequently visit the Preserve (75 percent of respondents visit at least once a month), we should consider this survey skewed towards current users.
 - It may be determined that serving those who already utilize the Preserve is the wise strategic direction in a limited funding environment.
- There is broad agreement on the amenities sought at the Preserve.
 Benches, shade structures, water features, educational signage and dirt trails were all popular amenity choices and were favored by all respondents, frequent uses, and those who have never visited the Preserve.
- Frequent visitors tend to be pedestrians. Less frequent visitors tend to drive a vehicle. We can likely assume that frequent visitors are also more likely to be from the neighborhoods that border the Preserve.
- Those who have never visited may be drawn in with greater number of dirt trails, shorter distance loops and trailheads.

A series of site visits were conducted by Sites Southwest representatives from November 14, 2022, through November 18, 2022. The purpose of the field reviews was to develop a thorough understanding of the existing conditions and operational needs of the Preserve. During these investigations, the following observations were documented.

- 1. Listing of Current Site Uses The current uses at the Preserve include the following:
 - The existing 6.2 miles of concrete cart path, which ranges in width, is being used as a multi-use trailway. User types observed included:
 - A. A wide range of recreational bike types, including electric bikes
 - B. Electric scooters
 - C. Walkers
 - D. Joggers
 - E. A range of baby/kid stroller types, including jogger, double and bassinet styles
 - The parking area adjacent to the former golf course clubhouse is being used as a trailhead.
 - The parking area adjacent to the former golf course maintenance yard is being used as a trailhead.
 - Preserve Vistoso prepared a 174-page field guide that is available to the public and documents the plants, birds and mammals that inhabit the Preserve. The site is being used by individuals and organized groups for habitat viewing and photography.
 - The site is being used by individuals and organized groups for dark sky viewing and photography.
 - Innovation Academy is developing programs that incorporate the Preserve.
- **2. Listing of Current Site Maintenance Operations –** Maintenance of the facility is currently outsourced to Brightview who's responsibilities include the on-going treatment and removal of invasive species and bermuda grass throughout the driving range, fairways, greens, and tee boxes.
- 3. Listing of Current Site Conditions During the initial review of the site, our team observed the following:
 - The site is being maintained and no areas of debris, trash and/or dumping were observed.
 - The cart path is being used as multi-use trail and is constantly occupied with a wide range of users.
 - Sections of the cart path are cracked and missing expansion joints.
 - Portions of the cart path have elevated curbing.
 - There are many sections adjacent to the cart path that have been filled with rock to addresses
 erosion concerns.
 - There does not appear to be shoulders along much of the cart path.
 - Sections of the cart path do not appear to meet ADA requirements for multi-use trailway use.
 - Sections of the cart path that cross existing washes are showing signs of erosion and undercutting.
 - The sightlines into and out of the cart path tunnels are narrow and the high of the tunnel is low. Additional signage may be needed to address safety concerns.
 - Sections of the cart path are located very close to the residential view fences.



- At grade road crossing of the cart path were noted. Additional safety signage should be placed in these locations.
- Trail rules and regulation signage has been installed along sections of the trail.
- Several social trails connecting the surrounding neighborhoods to the cart path were noted.
- Users are accessing the Preserve from the neighborhood social trails and the parking lots located at the former golf course club house and maintenance yard.
- A few "volunteer" mountain biking trails have been developed and mountain biking use was observed. Based on the conservation easement language, this is not a permitted use.
- The existing restrooms are currently under renovation.
- Portions of the existing irrigation system appear to have been damaged. Further information will be needed to determine if any of the system can be reused to establish future plantings throughout the Preserve.
- The former pond area was observed and based on community input, suggestions for this area include refilling with reuse water, filling with dirt, and/or creating a constructed wetland for wildlife habitat. A few dead trees were observed between the road and pond location.
- The former maintenance yard was observed, and it is recommended that this area, which is secured by walls and fencing, continue to be used to support future restoration and maintenance needs of the Preserve and Town operations. This area could also feature a trailhead.
- Bird feeders within the Preserve and adjacent to residents were observed in several locations.
- Clearing of portions of the Preserve adjacent to residents was observed in several locations.
- Site furniture, signage, real estate brochure boxes and accent lighting have been placed within the Preserve adjacent to residential areas.
- Invasive species and bermuda grass treatment and removal was observed at the driving range, fairways, tee boxes and greens. A sustainable phased revegetation plan that promotes habitat needs to be developed to address these areas.
- Based on the conservation easement language and our team's field observations, improvements to the site will need to address:
 - A. The long-term protection of the sites ecological and cultural resources
 - B. Providing education opportunities for a wide range of user groups that is inclusive of all ages
 - C. Creating site-sensitive passive recreational attributes
